- **Educational Licenses.** Educational licenses are granted to **educational agencies** for educational-use only (not for engineering or research) on a single computer at a single street address. Maintenance is included for two years.
- Educational licenses are granted to **students** in good standing for educational-use only (not for engineering or research) on a single computer for a single user at a single street address. Evidence of current enrollment must be provided. Maintenance is included for two years, after which time the license will expire and the program will be useable as a demo only.
- **Program Updates.** All updates and upgrades which are posted while a maintenance plan is in effect can be downloaded and installed at no charge via Internet download. Expired maintenance plans can be extended for another year with back payment pro-rated for the months since the prior plan expired. Upgrade prices to TEAPAC Complete (Ver 8) from earlier versions can be arranged directly with Strong Concepts -- credit will be given for recent license and update fees.
- **Documentation.** TEAPAC Complete (Ver 8) includes a complete, fully-indexed, on-screen Tutorial/Reference Manual linked to the program with context-sensitive buttons and hot keys. Printable PDF manuals are available at no charge via Internet download.
- **Order Processing.** Fee of \$19 covers delivery of license key via email to use with downloaded software installation. Orders received by 12 Noon Central time are normally processed and delivered via email the same day. Orders received later are normally processed and delivered the next day. Invoices are emailed for payment in PDF format.
